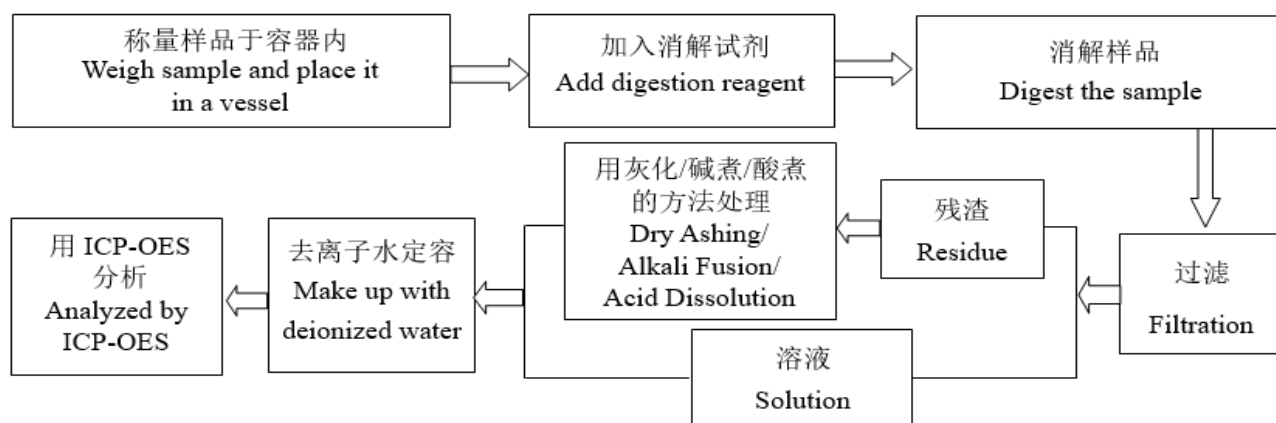

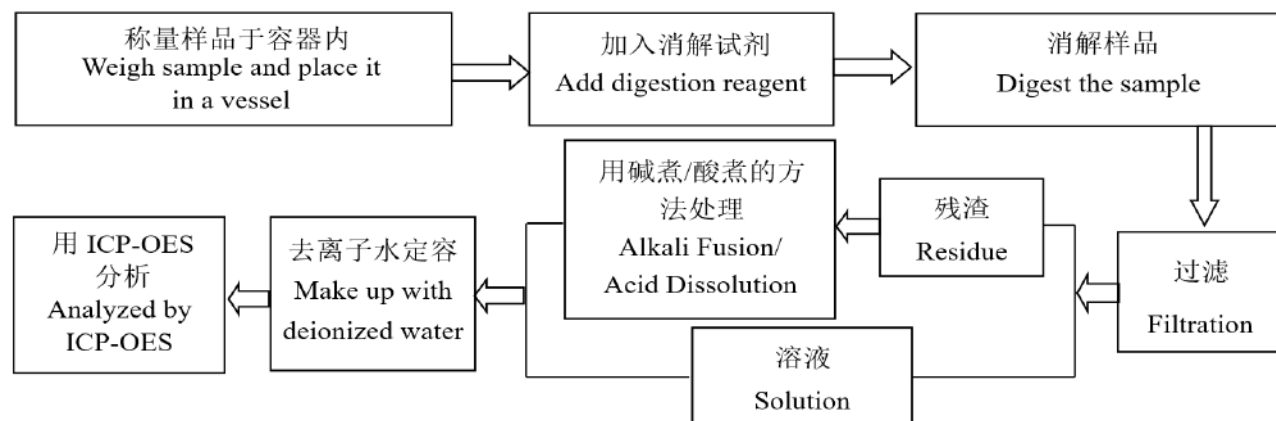

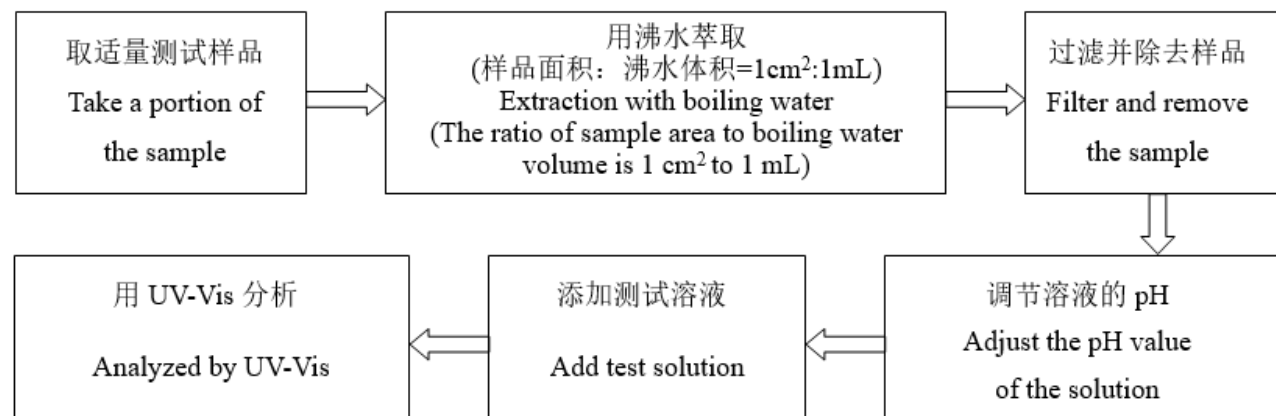
### 1. 铅 Lead (Pb), 镉 Cadmium (Cd)

### 3. 六价铬 Hexavalent Chromium (Cr(VI))



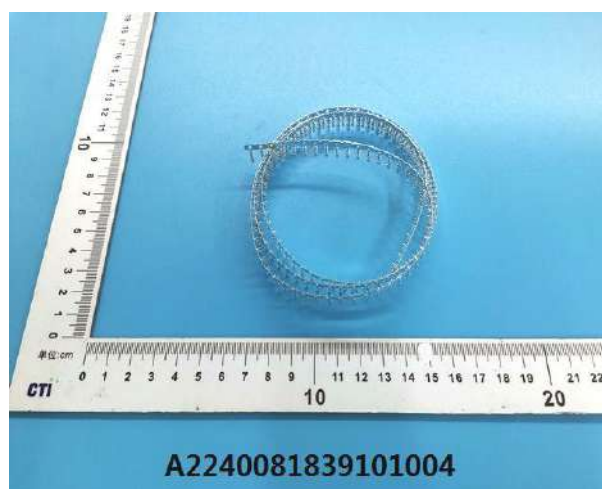
